Entries to the 2008 Wakefield Park Mini Series Race Meeting Round 1 is open to the following categories:

Each category will receive 1 x 10 minute practice session, 1 x 15 minute qualifying session, 3 races of 5 laps and 1 race of 8 laps duration.

7. LICENCE REQUIREMENTS

Racing - Competitors must hold a minimum AASA Level 2 licence, AASA or General Competition licence.

8. SAFETY REQUIREMENTS

8.1 Any vehicle which holds a log book must supply this to scrutineering with the vehicle.

8.2 Any vehicle competing must be fitted with approved roll over protection and must wear approved clothing as per standard racing requirements.

8.3 A limited number of race suits and helmets are available for hire from the circuit.

9. AUTOMATIC TIMING

9.1 The organisers utilise an automatic timing system, which requires all cars to be fitted with a Data 1 transmitter, which is the competitor's responsibility. Data 1 transmitters are available for purchase from Eldee Timing Solutions, Lisa Drayton – 0402 830 313.

9.2 Data 1 transmitters will be available for hire at the circuit from the Timekeeper at a cost of \$25 per unit.
